*All items listed below feature the Thumbprint Signature logo printed in red and black.*

► **Touch Pads** – the pads have a shelf life of 18 months or a minimum of 500 impressions. Banks should order enough for all tellers.

► **Teller Window Display** – banks should post these 3" x 6" tent-style signs at all teller windows as an additional reminder that they participate in the program.

► **Statement Stuffers** – these 3.5" x 7.5" brochures explain the mechanics of the program. Banks should use them as a public service announcement to all account holders and have plenty available for anyone who might have questions about the program. Please order in increments of 500.

► **Decals** – banks should post decals at all entrances and drive-up windows to let people know they are participating in the program and to warn potential criminals that their crimes will not go undetected.
